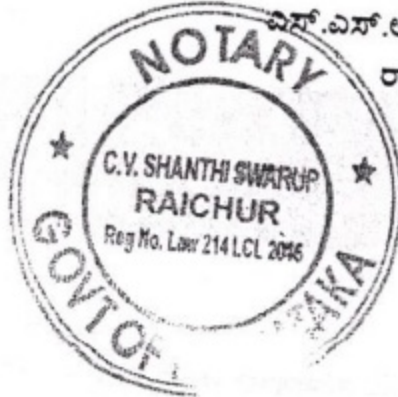

- Financial year of the A.A.SSRG Women's College Raichur will be from 1st April to 31st March.


6. Membership

8. General Body

- All the alumni members of A.A.SSRG Women's College constitute General Body.
- A General Body Meeting of A.A.SSRG Women's College, Raichur should be held at least once in a year.
- General Body members will be elected as the president, Vice-President Secretary, Joint secretary, Treasurer and seven executive committee members unanimously or through proper election.
- Among the elected members to the executive Council, the Vice-President, Secretary and Treasurer and three executive members shall be elected from the members residing at Raichur.
- The term of the President vice President, Secretary, Joint secretary and Treasurer and seven executive committee members is 2 years.
- To conduct election for new executive body minimum 15 days notice has to be given to call the General Body members for meeting.
- The General Body Shall be empowered for approval of the proceeding of the previous meeting

9. Executive committee

- Executive committee consist of the President, Vice President, Secretary, Joint Secretary and Treasurer and seven executive committee members, special invitee and Chief patron.
- The Chief patron will be the principal of s s r g Women's College Raichur.
- Special invitees Nominated by president in consultation with secretary and Chief Patron.
- The executive committee shall meet at least twice in a year.
- Quorum of minimum 6 elected members out of 12 is required to conduct executive committee meeting.
- The deferred meeting shall be conducted after the one hour of scheduled time when work is not there.
- The executive committee shall be mainly responsible for the functioning and development of the association.


- The executive committee may raise funds for the fulfilment of the objectives of the society.
- Any amount received by the executive committee by way of donation grant or membership subscription shall be kept in a schedule bank in the name of the association and the account shall be operated under the joint signatures of the president and secretary.
- The executive committee shall have the power to receive gifts to purchase order to obtain on lease any Movable property.
- The executive committee shall have power to appoint auditor for auditing the accounts of the association and for making a report there on.


10. Financial Matter

- The bank account shall be opened in any nationalised bank in the name of A.A.SSRG Women's College Raichur.
- It is operated under Joint Account, with three signatures namely Chief Patron and Treasure being compulsory and the third signature may be that of President or Secretary.
- A.A.SSRG Women's College Raichur shall accept gifts, donation are any other payments from SSRG Women's College Alumni working in India and Abroad and NRI category.
- A.A.SSRG Women's College shall accept gifts, donation from non members, voluntary organisations, Industries, companies in addition to the membership fee.
- All the money received by the A.A.SSRG Women's College, Raichur shall be acknowledgment and receipts issued such money shall be scheduled bank.
- The executive committee shall cause the audited accounts to be placed before general body meeting for approval as per section 11 of KSR act 1960.

11. Meetings

- President shall preside over all the meetings.
- In the absence of president the vice president shall preside over the meeting.
- Secretary shall convey the meeting and submit the reports. He shall also maintain all records of meetings.

- The treasurer has to maintain the accounts and produced the up to date accounts in the meetings.


12. The Seal

- The executive committee shall provide for the custody of the A.A.SSRG Women's College Raichur seal.
- The seal of the association shall not be affixed to any instrument expect by the authority of the executive committee and except in the presence of at least 2 members of the executive committee and the secretary.

13. Amendment

- Any amendment or alteration in the by-laws of the SSRG Women's College Raichur, may be proposed by any member and it should be passed and adopted by 2/3rd majority among the members present in the General Body Meeting, it should be in accordance with section 9 and 10 of the KSR act 1960.
- A.A.SSRG Women's College Raichur is dissolved to registered under IT Act, the following amendments are activated.
- No member shall receive any benefit directly or indirectly from the A.A.SSRG Women's College Raichur.
- These funds of the A.A.SSRG Women's College, Raichur should be invested in permissible securities as provided in the IT Act.
- That no claim should be altered or amended without the permission of the authorities with whom the A.A.SSRG Women's College Raichur is registered.
- In case of dissolution of the A.A.SSRG Women's College Raichur, no funds transfer to any members instead it can be merged or rested with any of the A.A.SSRG Women's College Raichur, having similar objects.


